Lisa stated that the calendar year ended with \$120.7 million in the pension fund. The assets increased for this period ending by \$1.7 million on revenues and expenses of \$2 million. The Village contributions for the three months were \$7,300 and employee contributions were \$262,000.

Craig Larsen from AHC was present to give a presentation to the Board. Craig stated that the Board owns the Vanguard admiral class mutual fund which has a low fee of .04%. Craig stated that Schwab has lowered the fee on their index fund to .03%. Craig stated that the Board has the opportunity to switch to the Schwab index fund and save \$750 a year with the same performance. Craig recommends exchanging the holdings for the Vanguard 500 index fund into the Schwab 500 index fund.

Roger Turk would like to schedule an Investment Sub-Committee Meeting in May.

A motion was made by Mark Nelson, seconded by Chief Walters to convert the Vanguard 500 index holding to the Schwab 500 index holding.
